Recommendatory legislative law of the Interparliamentary Assembly of Member Nations of the Commonwealth of Independent States (IPA CIS)

"On regulation principles of information relations within Interparliamentary Assembly Member States"

(St.-Peterburg, 1993).

- *Ensuring the rights of parties (subjects) of information relations.*
- *Institution of common legal conditions for realization of an information exchange in the states and between the states-participants of the Inter-parliamentary Assembly.*
- *Providing the information security, prevention of unauthorized intervention in information systems.*

Established in 1991.

Now unites 19 state-participants.
